

Although, DPSRU is just two year old University, started in 2015, it has strong legacy of 53 years i.e. college of pharmacy started in 1964, upgraded to research institute in 2004, Delhi Institute of Pharmaceutical Sciences and Research popularly known as DIPSAR with centre of excellence for research and amongst the first series of Quality Improvement Programme (QIP) centers of All India

The number of courses being offered in Diploma, UG and PG / Ph.D. also increased from 2 and 6 in 2014-15 to 5 and 15 excluding Ph.D. courses in 2017-18. From 2017-18 we are starting many other new courses.

The university in 2016-17 with its constituent college DIPSAR organized 3 major conferences (including National Conferences on Pharmacoeconomics and Outcome Research), 4 workshops on topics like non-materials, incubation and innovations, 2 brainstorming sessions and Guest lecture by eminent personalities from India, U.K, USA, Czech Republic in Canada and Russia. To expand horizons and promote research activities the universities entered into Memorandum of Understanding with Dabur foundations, Indian Pharmacopoeia Commission (IPC), Indian Renewable Energy Development Agency (IREDA), Sports Infrastructure & Talent Development Society (SITDS), International Centre for Medical Education and Research (ICMER), V ClinBio Lab, and Particle Sizing System US. To have effective administration on academics and research, along with close monitoring, the university holds regular meeting of Academic Council, Finance Committee and Board of Governors. The University is also starting "Incubation Center" to roll out startups. In addition to academics various extra curricular activities are organized within and outside the campus of the university, Some of such activities include celebrations of Lohri, Makar Sankranti, 68th Republic Day, National Voter's Day, Vasant Panchmi, Annual Sports Day and National Science Day. UNIVERSITY PROFILE

Delhi Pharmaceutical Sciences and Research University (DPSRU), is the first Pharmacy University of India, that established by an Act 7 of 2008 of State Legislature of Delhi as a State university vide Notification No. F.2(412)/2008/SB/Vol. III/71 dated 21.01.2010 and is empowered to award degrees as specified by the UGC under section 22 of the UGC Act 1956 through its own departments and constituent colleges in regular mode vide Notification No. F.9-19/2015(CPP-I/PU dated 22nd September 2015. Delhi Government legislation on 17th October, 2008 (Delhi Act 07 of 2008) and made functional from 2015-16. The university is situated in the University campus besides the old block. The university is recognized by UGC under section 2f. Life Sciences Sector Skill Development Council (LSSSDC) declared Delhi Pharmaceutical Sciences and Research University is accredited vocational training partner. NBA has accredited D. Pharm., B. Pharm. and M. Pharm. (Pharmacology) at DIPSAR, the constituent college of the University.

The Delhi Institute of Pharmaceutical Sciences and Research is one of the departments of Directorate of Training and Technical Education (DTTE), was founded in 1964 as a Department of Pharmacy at Kashmiri Gate Polytechnic for imparting Diploma in Pharmacy. The department was later on shifted to Pusa Institute and then to present campus at Pushp Vihar, New Delhi in 1979. College of Pharmacy was upgraded and named as Delhi Institute of Pharmaceutical Sciences and Research vide gazette notification of July 2004, under DTTE, NCT.

DPSR University is a non-affiliating University offering UG and PG programmes of various disciplines of pharmacy and allied sciences like physiotherapy, hospital management and

public health. The University has developed a reasonably good infrastructure in the form of classrooms, labs, library, playgrounds, guest house, faculty house, hostels etc to provide quality education to students. Having around 1000 students and around 150 staff members.

It has being developed as State of Art, well equipped Centre of Excellence and is producing top class pharmaceutical scientists, pharmacists thereby significantly contributing towards the development of World and India in particular.

A JOURNEY IN BRIEF

The journey started in 1964 as "Department of Pharmacy" of Directorate of Training and Technical Education (DTTE) at Kashmiri Gate Polytechnic, Delhi, for imparting Diploma in Pharmacy. This department was later on shifted to Pusa Institute where B. Pharm. Course was introduced in 1972, and M. Pharm. in 1979 and it was elevated to the 'College of Pharmacy'. It then moved to a bigger campus at Pushp Vihar, New Delhi. This College of Pharmacy was upgraded and named as 'Delhi Institute of Pharmaceutical Sciences and Research' (DIPSAR) vide gazette notification of July 2004, under DTTE, GNCT of Delhi affiliated to University of Delhi. DIPSAR is now a Constituent College of DPSRU, as per DPSRU Act. Delhi Pharmaceutical Sciences and Research University (DPSRU) and DIPSAR, commonly operate in the same campus, located in Pushp Vihar, New Delhi.

ADMISSION FORMALITIES

ELIGIBILITY CRITERIA FOR VARIOUS COURSES

Bachelor of Pharmacy (B. Pharm.) /Diploma in Pharmacy (D. Pharm.)

A candidate seeking admission to First Semester B. Pharm. or First Year D. Pharm. must have passed:

Senior School Certificate Examination of the Central Board of Secondary Education, New Delhi (12 year Course) or the Indian School Examination with English as one of the subjects and Physics, Chemistry, Mathematics (P.C.M) and/or Biology (P.C.B / P.C.M.B.) as optional subjects with 55% or above marks* in aggregate and individually in theory of the three Science subjects (Physics, Chemistry and Biology or Mathematics) from Recognized Schools in the National Capital Territory of Delhi.

OR

10+2 examination conducted by the respective state/central government authorities recognized as equivalent to 10+2 examination by the Association of Indian Universities (AIU) with English as one of the subjects and Physics, Chemistry, Mathematics (P.C.M) and/or Biology (P.C.B / P.C.M.B.) as optional subjects with 55% or above marks* in aggregate and individually in **theory** of the three Science subjects (Physics, Chemistry and Biology or Mathematics).

OR

Any other qualification approved by the Pharmacy Council of India as equivalent to any of the above examinations.

OR

Intermediate examination in science from Indian Universities or with English as one of the subjects and Physics, Chemistry, Mathematics (P.C.M) and/or Biology (P.C.B / P.C.M.B.) as optional subjects with 55% or above marks* in aggregate and individually in **theory** of the three Science subjects (Physics, Chemistry and Biology or Mathematics).

Candidates who have been awarded grades in the examination which make them eligible for admission should also submit conversion certificate of numerical marks from the concerned authority. The candidates who have passed 10+2 Examination from Open School are ELIGIBLE for admission to B. Pharm. 1st Semester.

Provided that a student should have completed 17 years of age on the date of admission or should complete the age of 17 years on or before 31st December 2017.

B. Pharm. Lateral Entry

A candidate seeking admission to B. Pharm. Lateral Entry (to Second Year/Third semester) must have passed D. Pharm. course from an institution approved by the Pharmacy Council of India under section 12 of the Pharmacy Act as per regulation 4.B. of the Bachelor of Pharmacy course Regulations, 2014.

Bachelor of Physiotherapy (B.P.T.)

A candidate seeking admission to First Semester Bachelor of Physiotherapy (BPT) must have passed:

Senior School Certificate Examination of the Central

Board of Secondary Education, New Delhi (12 year Course) or the Indian School Examination with English as one of the subjects and Physics, Chemistry, and Biology (P.C.B / P.C.M.B.) as optional subjects with 55% or above marks* in aggregate and individually in theory of the three Science subjects (Physics, Chemistry and Biology) from Recognized Schools in the National Territory of Delhi.

OR

10+2 examination conducted by the respective state/central government authorities recognized as equivalent to 10+2 examination by the Association of Indian Universities (AIU) with English as one of the subjects and Physics, Chemistry, and Biology (P.C.B / P.C.M.B.) as optional subjects with 55% or above marks* in aggregate and individually in **theory** of the three Science subjects (Physics, Chemistry and Biology).

OR

Any other qualification approved by the Delhi Council for Physiotherapy and Occupational Therapy, as equivalent to any of the above examinations

OR

Intermediate examination in science from Indian Universities or with English as one of the subjects and Physics, Chemistry, and Biology (P.C.B / P.C.M.B.) as optional subjects with 55% or above marks* in aggregate and individually in **theory** of the three Science subjects (Physics, Chemistry and Biology).

Candidates who have been awarded grades in the examination which make them eligible for admission should also submit conversion certificate of numerical

marks from the concerned authority. The candidates who have passed 10+2 Examination from Open School are ELIGIBLE for admission to B.P.T. 1st Semester.

Provided that a student should have completed 17 years of age on the date of admission or should complete the age of 17 years on or before 31st December 2017.

* A 5% relaxation will be given to SC/ST and OBC candidates seeking admission.

Note: a) The candidate having supplementary/compartment in the qualifying examination shall not be allowed admission in the University teaching department.

b) Migration of students will be governed by the Rules and Regulations of DPSRU, New Delhi.

Admissions to Foreign Nationals:

Eligibility is same as for general candidates.

It is mandatory to submit a migration certificate obtained from the respective university where the candidate had passed his/her qualifying degree

Master of Pharmacy (M. Pharm.) / M.B.A. (Pharmaceutical Management)

1. Eligibility Criteria for Admission:

A candidate seeking admission to First Semester M. Pharm. must have passed:

a) B. Pharm. Degree examination of an Indian university established by law in India from an institution approved by Pharmacy Council of

India and has scored not less than 55%* of the maximum marks (aggregate of theory II, III and IV yrs/or III to VIII semesters of B. Pharm.)

b) Every student, selected for admission to post graduate pharmacy program in any PCI approved institution should have obtained registration with the State Pharmacy Council or should apply for the registration of the same within one month from the date of his/her admission, failing which the admission of the candidate shall be cancelled.

It is mandatory to submit a migration certificate obtained from the respective university where the candidate had passed his/her qualifying degree.

* A 5% relaxation will be given to SC/ST and OBC candidates seeking admission.

2. Basis of Selection

Candidate seeking admission to the M. Pharm and MBA course must have passed the Bachelor of Pharmacy examination with at least 55% in the aggregate of theory of II, III and IV year from national capital of Delhi. GPAT QUALIFIED CANDIDATES SHALL BE CONSIDERED FOR ADMISSION FIRST. In case GPAT candidates are not available, Non GPAT candidates can be considered for admission, on the basis of merit.

First 15% of the total seats will be filled by Non-Delhi candidates with valid GPAT score and completed B. Pharm. examination with 55% from recognized University.

Remaining 85% of the total seats will be filled by

graduates passed out from Delhi colleges/universities with valid GPAT score in order of preference of disciplines. The merit list of candidates for admission to 85% seats from Delhi will be in accordance with the following criteria:

- 50% weightage for marks in theory II, III and IV yrs (or III to VIII semesters)
- 50% weightage for GPAT score

In case of more than one candidate with the same score, preference will be given to the candidate who is older in age. In case no GPAT students available in 15% Non-Delhi category, then student from Delhi category with GPAT will be considered.

In case sufficient numbers of Delhi students are not available against the 85% of seats, the seats will go to Non-Delhi students with valid <u>GPAT</u> score. After exhaustion of Non-Delhi GPAT qualified candidates, if seats still remain vacant they will be offered to Delhi-Non-GPAT applicants. Further, if seats still remain vacant the non Delhi Non-GPAT can be considered.

The merit list for Non-GPAT candidates will be prepared on the basis of total of theory examination of II, III, IV year (or III to VIII semesters)

3. Age Requirement

Candidates seeking admission to M. Pharm. course must be more than 21 years of age as on 31st December 2017.

4. Submission of Application and Display of Merit List

The final merit list for all categories of M. Pharm.

will be displayed on the Notice Board/Website of the University. Admission to various courses will be offered to the candidates strictly according to the order of merit given in the merit list.

Master of Hospital Management (M.H.M.)/ Master of Public Health (M.P.H)

Eligibility Criteria for Admission: A candidate seeking admission to First Semester, must have passed:

- a) B. Pharm. / M.B.B.S. / B.D.S. / B.H.M.S. / B.U.M.S. / B.A.M.S. Degree examination of an Indian university established by law in India from an institution approved by their respective Councils of India (PCI, MCI, DCI, AYUSH, Homoeopath, Ayurved, Unani councils) and has scored not less than 55 % of the maximum marks.*
- b) Every student, selected for admission to post graduate program in any council approved institution should have obtained registration with the State Council or should obtain the same within one month from the date of his/her admission, failing which the admission of the candidate shall be cancelled.

It is mandatory to submit a migration certificate obtained from the respective university where the candidate had passed his/her qualifying degree.

* A 5% relaxation will be given to SC/ST and OBC candidates seeking admission.

Doctor of Philoshphy (Ph.D.)

The details for admission to Ph.D. program will be notified separately. As per the UGC guidelines, admission test will be conducted and there will be a provision for scholarship/fellowship to the students.

Students having fellowship from any recognized national/ state agencies are exempted from the admission test as per UGC rules and may apply directly to the University through the recognized Ph.D. teacher at the University or its constituent college (DIPSAR) on or before 31st August 2017.

Sports Pharmacy and Management Skills programs

University will be starting new courses in sports pharmacy and management skills from 2017-18. A separate prospectus and notification will be published.

Certificate Courses in Yoga

University is currently running evening 6 month certificate courses. Student can get admission for courses start from July 2017 or January 2018.

Candidate has to submit application form with requisite fee of Rs. 3000/- (including examination fee). A maximum of 30 students can be enrolled at a time. Admissions will be given on the first-cum-first basis.

RESERVATIONS

Provision for Scheduled Caste / Scheduled Tribe / Other Backward Class Candidates

22.5% of the total number of seats (15% for Scheduled Castes and 7.5% for Scheduled Tribes) of the course are reserved for Scheduled Caste and Scheduled Tribe candidates. 27% of seats within Delhi category are reserved for OBC students. In case of non availability of ST candidates, the seats available are to be converted to SC category. In case non-availability of OBC the seats to be converted to general category. If the reserved seat (SC/ST) still remains vacant, further relaxation shall be given to the extent required in order to fill up all the reserved seats.

If the reserved seat (SC/ST) still remains vacant, further relaxation shall be given to the extent required in order to fill up all the reserved seats.

A Scheduled Caste / Scheduled Tribe candidate while applying for registration for any of the course will be required to submit a verified certificate to the effect that he/ she belongs to Scheduled caste/ Scheduled Tribe, from the competent authority with the application form. Delhi category students have to produce caste certificate (SC/ST/OBC) from appropriate authority of Govt. of Delhi as given below.* The non-Delhi SC / ST candidates have to produce the caste certificate from the competent authority of their respective state. These certificates will be duly verified by the Admission Officer.

i. District Magistrate / Additional District Magistrate/ Deputy Commissioner / Collector / Additional

Deputy Commissioner / Deputy Collector / 1st Class Stipendiary Magistrate / Extra Assistant Commissioner

- ii. Chief Presidency Magistrate/ Additional Chief Presidency Magistrate/Presidency Magistrate
- iii. Revenue Officer not below the rank of Tehsildar. Class Stipendiary Magistrate/Extra Assistant Commissioner
- iv. Sub- Divisional Officer of the area where the candidate and /or his/her family normally resides.
- v. Administrator/Secretary to Administrator/ Development Officer (Lakshwadeep and Minicoy Island).

*Reservation subject to circular communicated by Delhi Government Provision for Children/Widows of the Officers and men of the Armed forces including paramilitary personnel killed or disabled during hostilities and also who died on duty (Defence Category).

- i. The Children/Widows of the officers and men of the Armed Forces including paramilitary personnel killed or disabled during hostilities and also who died in duty will be given concession of 5% marks in the minimum eligibility conditions as per rules of University.
- ii. Children/Widows of Officers and men of the Armed Forces including para-military personnel who died while on duty will be considered for admission against 5% seats for all the Armed forces including paramilitary personnel, killed or disabled in action in wars 1947-48 onwards.

In the above 2 categories seats will be offered in the following order of preference:

(If no such candidates available the seats to be filled by candidates of general category)

- i. Widows/Wards of Defence-paramilitary personnel killed in action.
- ii. Wards of serving personnel and Ex-servicemen disabled in action.
- iii. Widows/Wards of Defence-Paramilitary personnel who died in peace time
- iv. Wards of Defence-Paramilitary personnel who were disabled in peace time with disability attributable to military service.
- v. Wards of Ex-servicemen and serving personnel who are in receipt of Gallantry Awards:-
- a) Param Vir Chakra
- b) Ashok Chakra
- c) Sarvottam Yudh Seva medal
- d) MahaVir Chakra
- e) Kirti Chakra
- f) Uttam Yudh Seva medal
- g) Vir Chakra
- h) Shaurya Chakra
- i) Yudh Seva medal
- j) Sena, Nausena, Vayusena medal
- k) Wards of ex-serving personnel.
- I) Wards of serving personnel.

In order to become eligible for the above concession the widows/children of officers and men of Armed Forces

including paramilitary personnel will be required to produce an entitlement certificate from any one of the following authorities.

- a) Secretary, Kendriya Sainik Board, Delhi
- b) Secretary, Rajya/Zila Sainik Board
- c) 1st Class Stipendiary Magistrate.
- d) Head of the battalion or unit

Admissions of students to various courses in academic session 2017-18 in view of the OBC reservations

The reservation of seats for OBC candidates, if any, will be implemented in accordance with the reservation policy of the Delhi Government. In accordance with the above, the following procedure for admission of the OBC candidates to all the courses will be followed. It is reiterated that the OBC candidates under Delhi Category who belong to the 'Non-Creamy Layer' and whose castes appear in the Delhi List of the OBCs only shall be eligible to be considered for admission under the Delhi-OBC Category on producing certificate from appropriate authority only. The unfilled OBC seats available are to be converted to general category.

- 1. In accordance with the Cabinet decision No.1869 dtd 27/2/12, the percentage of reservation for OBC students will be 27% in the academic year 2017-18.
- 2. The OBC candidates shall be given a relaxation in the minimum eligibility in the qualifying examination to the extent of 5% of the minimum eligibility marks prescribed for the General Category Candidates.

- 3. All those OBC candidates who meet the minimum eligibility marks in the qualifying examination shall be eligible for admission in the order of their merit, keeping in view the availability of seats reserved for them.
- 4. If the seats reserved for the OBC remain vacant, the said seats shall be filled with the OBC students. Only if OBC candidates possessing the minimum eligibility marks are not available in the OBC category then the vacant OBC seats shall be converted into General Category seats in accordance with the admission schedule notified by the University.
- 5. The candidates to this category, certificate has to provide issued after 01/01/17 on Non-Creamy layer certificate.

Candidates belonging to State where there is no Diploma Course in Pharmacy

Candidate from state where there is no government Diploma Course in Pharmacy will be admitted against one seat reserved for such States.

Such candidates must have passed the Qualifying Examination from the State to which they belong and must be nominated by the State Government concerned DTTE.

Last Date for receipts of such application will be 07/07/2017.

Foreign National and Candidates Belonging to the Countries/States Where there is No Degree Institute in Pharmacy

One seat for candidates from other States, where there is no government Degree college in Pharmacy will be reserved provided they fulfill the minimum eligibility conditions laid down in this behalf.

The foreign nationals must fulfill the eligibility conditions for the admission to the course. The application must be processed through their Embassy as per the rules and fees existing for foreign students. The applicant has to submit the copy of the application to university directly. Any foreign student application submitted, forwarded to the DPSRU for processing. These seats are supernumerary and not exceeding 5% of total intake. If the application is more than one from one foreign country then only one candidate is allowed to take admission from each country. Supernumerary seats for Kashmiri migrant students as per AICTE norms.

The candidates from the states where there is no government Degree College in Pharmacy must have passed the qualifying examination from the state to which they belong.

Handicapped Students

The physically handicapped students are advised to apply online with disability certificate issued by the competent authority and verified with Admission Committee in order to consider their cases for admission to Under-Graduate courses. These seats are supernumery and maximum up to 3%. The Chief Admission Officer will have right to decide the eligibility for the admission.

HOW TO APPLY

No offline application form would be distributed, candidate have to apply online only for the admission process.

Online Application

Candidates shall visit http://forms.dpsru.edu.in/ and apply online to the University for admission and pay the fee of Rupees 1000/- (Rupees one thousand only) through Net Banking / Debit Card / Credit Card as required in the online process. No print of form will be required to be sent to the University. The acknowledgement slip generated online as a proof of payment must be retained. Last Date for applying will be 07/7/2017.

Application Forms for D. Pharm., B. Pharm. and M. Pharm. courses will be submitted online with scanned copies of Mark Sheet, Date of Birth, Category Certificate and GPAT Score Card (for M.Pharm. only), if any. Incomplete application forms without scanned copies will not be accepted. At the time of admission, all the original certificates and undertakings should be brought failing which admission will not be given and no request/relaxation will be entertained in this regard, along with Annexure given in the prospectus (Annexure I to III). In respect of M. Pharma, Ph.D. and lateral entry students of B. Pharm., there is a mandatory requirement to submit an undertaking for Pharmacist Registration Certificate within one month of admission in respective course as per the Annexure-IV.

Admission will be made strictly according to the merit, *i.e.* aggregate marks obtained in the qualifying subject

prescribed for admission to the course subject to the reservations.

The consolidated merit list on the basis of the aggregate in the qualifying subjects including general and reserved candidates shall be displayed on the notice board/website on the date indicated.

Foreign students or students from other states lacking pharmacy education facilities shall sponsored by the concerned Embassy/agencies. The Deptt. of Education, Ministry of Human Resource Development, Govt. of India, is only a reservation agency and does not by itself nominate any candidate requisite qualification prescribed for the course. Such applications must reach the Registrar, Delhi Pharmaceutical Sciences & Research University (DPSRU), Pushp Vihar, New Delhi – 110017 on or before 07-07-2017. No further extension shall be given and applications received after the last date of submission shall not be entertained.

Examination Fee

(To be paid for end-semester examinations as and when announced):

Regular exam fee: Rs.3000/- (Semester or annual as applicable)

Back log paper examination: Rs. 500/- per paper

The fees and other charges mentioned in the prospectus may be revised by the University at any time without notice. In the event of such revision, all the enrolled students shall pay at the revised rates.

Refund of Fees

The refund of fees paid at the time of admission or during the course is governed by AICTE norms. Any claim for refund of Caution fee should be made within three years of completion of course along with original receipt, else the fee will be forfeited and returned to Government Account.

Payment of Dues

All dues shall be cleared by the dates mentioned in the prospectus or as notified by the DPSRU authority from time to time.

Financial Assistance

The detailed rules and regulation on the subject may be obtained from the office of the University. The financial assistance, available to students of full time courses, in accordance with relevant rules, are as follows:

Fee Concessions

Scholarship Holders: Holders of the following scholarships shall be exempted from payment of <u>tuition</u> <u>fee</u>, on application. (NTSC or DST Inspire)

Sister/brother Concession: In case two or more brothers/ sisters are admitted in the university the brother/sister studying in the lower class shall pay half the prescribed Tuition fee.

No Tuition fee shall be charged from son or daughter of employees of Training and Technical Education, Government of Delhi.

SC / ST students: Students belonging to the Scheduled Castes/ Tribes shall be exempted from payment of tuition fee.

Late Fee Fine

If the dues (other than those payable at the time of admission) are not paid by the due date, late payment fine of rupees one hundred for each day after the due date (including holidays) shall be realized, subject to a maximum of Rs.3000/- only.

If the fee is not paid within thirty days after the due date (including holidays) for any reason whatsoever, the name of the defaulter student shall be struck off the rolls of the university without any notice.

Payments of Fines and Dues

Students shall pay on demand any fine imposed on them or the cost of any damage to or loss of library books, equipment or other property of the university. On failure to do so the same will be recovered from the caution money which shall be reimbursed by the student within the time specified by the Registrar. If the cost of any damage to be recovered or loss exceeds the amount of caution money the balances shall be deposited by the student on demand by the Dean University. Failure to do so, may result in the removal of the name from the rolls of the university.

The students shall clear all dues to the university before they are permitted to appear in the annual/end-semester examination. If the dues are not cleared, there admit card/ provisional certificates will be withheld.

Striking off Rolls

The name of the student may be struck off the rolls on account of:

- i. His own written request, endorsed by his parent/ guardian;
- ii. Irregular attendance and poor progress in studies;
- iii. If ordered to be **EXPELLED** or **RUSTICATED** on account of indiscipline by the competent authority of the University;
- iv. Non-payment of tuition fee and other dues for 30 days after the last date of payment. The concerned university authorities. However, university may grant not more than 30 days of grace period to deserving cases on application by the parent/guardian.

Eligibility for Appearing in the Semester / Annual Examination

Only students Securing 80% attendance or above in both theory and practical classes taken separately are allowed to appear in the annual examination.

DISCIPLINE

All the students admitted to the Institute will be under the complete disciplinary control of the Director of the Institute or any other officer(s) appointed by him for the purpose and must conduct themselves in accordance with the disciplinary rules of the University as framed and notified.

RAGGING

In accordance with the order of the Hon'ble Supreme Court dated 10.12.2007, in the Special Leave to Appeal (Civil)NOS 24295 and 24296-99 of 2004, "if any incident of ragging comes to the notice of the authority, the concerned student shall be given liberty to explain and if his explanation is not found satisfactory, the authority would expel him from the institution."

The candidates seeking admission have to give an undertaking that they will abide by the rules and regulations prescribed and abide by an action taken in this regard against students by the Vice-Chancellor.

Ragging in any form is strictly prohibited within the premises of University as well as on public transport.

Ragging, for the purpose of the Ordinance, means any act, conduct or practice by which dominant power

or status of senior students, is brought to bear on students freshly enrolled or students who are in any way considered junior or inferior by other students and includes individual or collective acts or practices which:

- a) involve physical assault or threat or use of physical force;
- b) violate the status, dignity and honor of women students;
- c) violate the status, dignity and honor of students belonging to the scheduled castes and tribes;
- d) expose students to ridicule and contempt and affect their self esteem;
- e) entrain verbal and aggression, indecent gestures and obscene behavior.
