ELIGIBILITY CRITERIA:

- (a) Have Name in common merit list of AIA-PGET-2017
- (b) Have passed B.A.M.S. course from any Ayurvedic College recognized by Central Council of Indian Medicine (CCIM), New Delhi.
- (c) Are Registered with any State/Central Council of Indian Medicine (CCIM), New Delhi.
- (d) Have completed/will be completing Rotatory Compulsory Internship by 30th September, 2017.

DURATION OF THE COURSE:

The Course Study for the Post-Graduate Degree of Ayurveda Vachaspati / Dhanvatari - MD/MS(Ayurved) is of three years duration having two Examinations as under:

- (1) Part-I (Preliminary) Examination at the end of one academic year after admission.
- (2) Part-II (Final) Examination at the end of two academic years after completing Part-I Course.

The candidate has to submit the Thesis six month before completion of their study tenure. In case he/she fails to submit the Thesis within the stipulated period, he/she will not be allowed to appear in the final examination.

STIPEND

Stipend will be paid to the PG students of Rishikul Campus (Haridwar), UAU/ Gurukul Campus (Haridwar), UAU as per Uttarakhand Government rules except Self Financing seats.

RESERVATION

- 50% seats are reserved for Uttarakhand State (those who are domicile of Uttarakhand state and/or passed BAMS from Uttarakhand) & remaining 50% seats for other States.
- Reservation for Uttarakhand seats will be as per rules of Uttarakhand Government & for other states seats as per Central Government rules.
- One seat in each institution will be reserved for Kashmiri Migrant.

INFORMATION BROCHURE

1. GENERAL

- (i) Seats are available in RISHIKUL CAMPUS (HARIDWAR), UAU, GURUKUL CAMPUS (HARIDWAR), UAU, UTTARANCHAL AYURVEDIC COLLEGE, DEHRADUN, HIMALAYIYA AYURVEDIC COLLEGE DOIWALA, DEHRADUN AND PATANJALI AURVIGYAN AND RESEARCH INSTITUTE, HARIDWAR for the Academic year 2017-18 for admission to 150 seats in MD/MS (Ayurved) Ras Shastra Evam Bhaishajya Kalpna, Shalya Tantra, Panchkarma, Samhita Sanskrit Evam Siddhant, Swasthavritta, Dravyaguna, Agadatantra, Prasuti Avum Striroga, Shalakya, Kayachikitsa, Kriya sharer, Rachana sharer, Rognidan and Kaumarbhriya. out of which 75 seats shall be filled by those candidates who are domicile of Uttarakhand or Passed BAMS from Uttarakahnd and 75 seats shall be filled by the candidates from other States. These seats of MD/MS (Ayurved) are subject to the permission for admission from CCIM/Govt. of India.
- (ii) Admission will be given on available seats in post graduate courses through Counseling on merit cum choice basis.
- (iii) A candidate who is already admitted to any post graduate course will not be eligible to get admission till he/she completes the course and passes the examination.
- (iv) The MD/MS (Ayurved) course shall be of 03 year duration.

2- SELECTION CRITERIA:-

- (i) In case of candidates obtaining equal marks, merit will be determined in order of preference as under:
 - (a) Candidate obtaining higher average aggregate percentage of marks in all professional exams. If obtained equal marks then,
 - (b) According to age i.e. older getting preference over younger.
- (ii) The allotment of course to the eligible candidates shall be made by the Counseling Board under chairmanship of Honorable Vice Chancellor on personal appearance, along with all original documents as per his/her merit and choice of the course. The date and place of Counseling shall be notified through website www.uau.ac.in. No intimation will be sent to the candidate by post. It will be the responsibility of the candidates to check these dates and appear for Counseling and allotment of course. The candidate will have to deposit a fee of Rs. 6,000/- at the time of Counseling thorough

Bank Draft. All available seats in different courses shall be displayed along with its recognition status at the time of Counseling. The candidate may choose any one of the available seats according to their merit. A seat once allotted to candidate for any course shall be final.

- (iii) **Rs. 30,000/-** will have to be deposited by the candidates as advanced tuition fee after allotment of seat. Candidates are allowed to appear for re-counseling only after depositing **Rs. 6,000/-** Counseling registration fee. Those candidates who failed to take admission after allotment of seat, his/ her advanced tuition fee will be forfeited. Those candidates who wish to withdraw admission after last counseling, he/she will have to deposit entire course fee, only after that University will issue Migration Certificate. All the fee will be deposited through Bank Draft.
- (iv) In first Counselling first of all seat of PH candidates and Kashmiri Migrants will be filled, in case of non availability of sufficient number of PH candidates and Kashmiri Migrants, these seats will be filled by other candidates of same category.
- (v) In last Counseling first of all ST/SC seats will be filled up by interchanging, if further remains vacant than these seats will be filled by OBC category candidates. In case of non availability of sufficient number of OBC category candidates, these seats will be filled by general category candidates.
- (vi) Students engaged in Anti National Activities / Anti University Activities / Anti Academic Protest / Anti Ragging Activities etc. will be expelled from the Institute / University and further proceedings will be initiated against him/her as per law.
- (vii) All the candidate will have to furnish an affidavit on Rs. 100/- non-judicial stamp paper in detail and bank guarantee of Rs. 2.00 lacs at the time of admission.
- (viii) Rules of Counseling and admission will be same as for UAPMT and vice-versa.

3. ADMISSION

- (i) Admission in MD/MS(Ayurved) course shall be given only after the candidate produces following original documents at the office of Director /Principal, Rishikul Campus (Haridwar), UAU/ Gurukul Campus (Haridwar), UAU, Uttaranchal Ayurvedic College, Dehradun and Himalayiya Ayurvedic College, Doiwala, Dehradun and Patanjali Ayurvigyan and Research Institute, Haridwar.
 - (a) High School certificate as proof of date of birth.
 - (b) Original Mark sheets of all professional Examination.
 - (c) B.A.M.S. passing out certificate or degree.
 - (f) Employer's relieving certificate, if employed.
 - (d) Compulsory Rotatory internship completion certificate.
 - (e) Permanent Registration Certificate of Indian Medicine Board
 - (g) S.C./S.T./O.B.C/PH Certificate, if applicable.
 - (h) Allotment letter, issued by Chairman, Counselling Board.
 - (i) Admit Card of AIA-PGET.-2017.
 - (j) Score Card of AIA-PGET.-2017.
 - (k) Domicile certificate on prescribed Performa.
 - (J) Adhar Card

- (ii) Candidates shall be required to complete the admission formalities and join the course assigned to them within specified period notified by the University.
- (iii) At the time of Counseling reservation policy will be applicable as per order of the Govt. of Uttarakhand / Govt. of India.
- (iv) After allotment of the seats candidates who failed to join the course within the specified period shall forfeit the right of admission and the security fee.
