## **TRIPURA UNIVERSITY: A PROFILE**

Tripura University was established under the Tripura University Act, 1987 on 2nd October 1987, as a State University, with the objective of facilitating the growth and quality of education among the people of the State in areas of contemporary relevance to the society and the country. The UGC granted its recognition as University under Section 12B of the UGC Act on May 1998.

Subsequently, Tripura University was converted to a Central University under the Tripura University Act, 2006 (9 of 2007) with effect from the 2nd day of July, 2007.

The University has at present two Faculties, the Faculty of Arts & Commerce and the Faculty of Science. At present Tripura University offers a total number of 46 programmes, which includes certificate courses, Under Graduate, Post Graduate Diplomas and Post Graduate Programmes.

Besides the above courses, the University also offers Ph.D Programme in 33 subjects. The University also provides academic support to 52 affiliated Degree Colleges in the State by way of formulating the curricula, supervising academic programmes and conducting examinations.

During the last nine years, the University has made impressive development in diverse arenas of education, studied and addressed social problems and promoted scientific research. The Placement Cell of the University provides help and support to the Students through campus interview. The University also conducts NET coaching classes/ tutorials for SC/ST/OBC students.

The University campus is growing fast and equipped with facilities like Bank and ATM service, Water Treatment Plant, Health Centre, Guest House, Central Library, Indoor and Outdoor Auditoriums, Eco-Park, Cafeteria etc.



## **DIRECTORATE OF DISTANCE EDUCATION**

Education has continued to evolve, diversify and extend its reach and coverage to all since the dawn of human history. An urge for knowledge is not only essential but also an inevitable facet of present day living. Any state or any part of the country that lags behind in the intellectual competition is sure to end up in disaster.

Any student passing H.S (+2) examination or its equivalent with at least 4 subjects including English from any recognized Board/ Council shall be eligible for admission to the 1<sup>st</sup> Semester of the BA General Programme of studies.

Under Graduate Programmes under Directorate of Distance Education shall be governed by the Rules and Regulations of Choice and Credit Based Six Semesters B.A/B.SC/B.COM General and Honours and amendments made from time to time.

## **GENERAL INFORMATION:**

Mere Possession Of Eligibility Conditions does not ensure Right To Admission in any programmes under the Directorate of Distance Education (DDE), Tripura University. The Cut-Off Marks for Admission to all ODL Programmes under DDE shall be determined by the Admission Committee duly constituted by Tripura University and the decision of the committee shall remain inviolable.

### **Academic Session:**

Each Academic Session shall commence from the month of July.

## **Admission Procedure:**

### **The Distance Education Admission Eligibility Test (DEAET):**

The Tripura University will conduct the 'Distance Education Admission Eligibility Test' (DEAET) for different Post Graduate (viz. Political Science, Education and Bengali) Programmes in Tripura University, Suryamaninagar failing which the applicant's candidature will not be considered/ entertained for admission. The counterfoil mark as "Acknowledgement-cum-Admit Card" must be produced at the time of the Admission Test in the DDE, TU. No separate call letter will be sent and no TA/DA will be paid to the candidates for appearing in the DEAET.

Mere receiving "Acknowledgement-cum-Admit Card" does not give anyone right to appear in the DEAET or seek admission to any programme under DDE, Tripura University.

### **Attestation:**

The Photograph in the Application Form and other papers maybe self-attested.

### **Selection for Admission:**

#### **Selection Procedure for Post Graduate Programmes:**

The selection of Candidates for admission to Post Graduate Programmes shall be made on the basis of the merit list of the 'Distance Education Admission Eligibility Test' (DEAET) conducted by the DDE, Tripura University.

### **Reservation:**

Reservation of seats for SC/ST/OBC (Non Creamy Layer)/Persons with Disabilities (PWD) shall be as per the Central Educational Institutions (Reservation in Admission) Act, 2006 (No.5 of 2007) and Amendment Act, 2012 (No. 31 of 2012) published in the Gazette of India by the Ministry of Law and Justice, Government of India or as amended from time to time. 2% Supernumerary seats are available for students of Jammu and Kashmir.

**Medium of Instruction:**

Except for language subjects, the medium of instruction/examination in the DDE, Tripura University for all Programmes is English. The deliberations in the classrooms during Personal Contact Programme shall be in English medium other than the language subjects. Candidates shall have to write all Examination Papers as well as Assignments only in English (except in language subjects).

## Internal Assessment:

### 1. Master of Arts (MA):

Internal Assessment shall be carried out as per the decision of the concerned faculty. However, a student must work out at least one Assignment for each Paper with or without Project/Viva Voce/Written Test.

### 2. Bachelor of Arts (BA), Certificate Course in Human Rights (CHR):

A Student has to prepare 1 (one) Assignment for each Paper of each Subject.

All assignments and model questions etc. Shall be available in the Tripura University Website. No hard copy of assignments, model questions etc. Will be given to any candidate/learners. Candidates/learners shall have to download the same from the Tripura University Website: [www.tripurauniv.in](http://www.tripurauniv.in).

## Assignments and Evaluation of Assignments

A Student shall prepare Assignments and submit the same to the DDE within specified dates. A Candidate shall have to work out Assignments for each paper and send them under Registered Post or submit in person to the Directorate of Distance Education, Tripura University, Suryamaninagar-799 022 within dates specified by the above office. Assignments reaching beyond the last date will disqualify Candidates from appearing in the Semester End Examination.

Students are required to prepare Assignments in their own hand writing and in their own language. Copying from anywhere or by any means is strictly prohibited. 6. Copying from the Response Sheets of other Candidates is disallowed. If copying is detected, the Assignments of both candidates shall be rejected.
7. Each Assignment must be written separately. Students must not mix up all Assignments together.

## Online Application

### Academic Session 2017-2018

- Online applications portal in the website [www.tripurauniv.in](http://www.tripurauniv.in) is open for Indian applicants for admission in various academic programmes of Directorate of Distance Education, Tripura University for the academic session 2017-2018.
- The online application portal shall remain open as mentioned below :
  - For Distance Mode: from 1<sup>st</sup> March 2017 10:00 IST to 31<sup>st</sup> May, 2017 24:00 IST.
- When an applicant visits the admission portal, he/she shall find two options.
  - For Regular Mode applicants
  - For Distance Mode applicants
- All relevant information may be found in the prospectus for the Distance Mode available in the website [www.tripurauniv.in](http://www.tripurauniv.in). Applicants may download the prospectus from the website of the University.
- Applicants in the Distance Mode can apply for all three programmes. While filling up the forms, they are advised to repeat the same process for each programme.
- After an applicant enters the portal, he/she shall get the list of programmes for which one may apply followed by information in detail besides the general information.
- For each program, he/she has to apply separately. Applicants have to go through the entire process each time s/he applies for a programme (like registration, submission of requisite fees, filling up online form etc.) irrespective of the number of programmes applied for.
- Applicants should read all the instructions carefully before registration and filling the application form online.

## **Rules and Regulations for Admission in Post Graduate Programmes under Directorate of Distance Education, Tripura University-2016**

### **1. GENERAL RULES:**

- A. This shall be called the “Rules and Regulations for Admission in Post Graduate Programmes under Directorate of Distance Education, Tripura University-2016” and this shall be applicable to all Post Graduate Programmes offered by Directorate of Distance Education, Tripura University.
- B. This Rules & Regulations shall be effective from the Academic Session 2016–2017 for admission into all Post Graduate Programmes under Directorate of Distance Education, Tripura University.
- C. One Officer-In-Charge shall be appointed by the Vice- Chancellor, Tripura University for conducting the Distance Education Admission Eligibility Test (DEAET).
- D. IV. In each academic year, admission shall be completed by 15th July.
- E. In case of any (i) failure in the online system (ii) failure of payment through bank, or (iii) any other unforeseen circumstances leading to failure in submission of form etc., the Tripura University authority shall not remain responsible.
- F. VI. All litigations regarding admission shall lie within the jurisdiction of Tripura High Court.

### **2. NOTIFICATION:**

- A. Notification for Admission to Post Graduate programmes shall be published by the Directorate of Distance Education, Tripura University at least 60 (sixty) days prior to the DEAET.
- B. The Distance Education Admission Eligibility Test (DEAET) for Admission into Post Graduate Programmes shall ordinarily be conducted on the last Saturday and Sunday of the month of May of each Year.
- C. Leaflets and Posters shall be published for wide Circulation regarding Programmes of DDE as well as Admission.

### **3. APPLICATION FOR ADMISSION:**

- A. Application form and necessary instructions shall be made available in the Tripura University Website [www.tripurauniv.in](http://www.tripurauniv.in). Students shall have to apply ONLINE only.
- B. Form Submission through Online shall commence in the middle of February and shall be closed on end of April. A student may apply for all post graduate programmes as offered by DDE. However, he/she shall be admitted only in one Programme.
- C. Prospectus shall be sent to the student concerned by Registered Post. However, for incorrect address or for any other reasons, if prospectus does not reach to the candidate concerned, the Directorate of Distance Education, Tripura University shall not be liable.
- D. **Students shall have to deposit Rs. 130.00 (Rupees One hundred Thirty) only for getting the prospectus by Registered Post in addition to Application and Prospectus Fee.**

#### **4. ELIGIBILITY CRITERIA FOR APPLYING FOR ADMISSION:**

- I. A Candidate who has successfully passed the Three-Year or Six Semester Bachelor's Degree (Pass or Honours) of this University or any other recognized University under 10+2+3 pattern or equivalent system of education shall be eligible to apply.
- II. A Candidate who has appeared in the examination of final year of Three Year/Six Semester degree programme shall also be eligible for applying for admission in the Post Graduate Programmes offered by the Directorate of Distance Education.
- III. A Candidate who is of Two Year Degree Course is not eligible to apply for appearing in the Distance Education Admission Eligibility Test.

#### **5. FEES:**

- I. A Candidate shall have to deposit the requisite fee for Application for Admission as determined by the University from time to time. However, for applying into more than one Programmes Candidates shall have to deposit separate Application fee for each Programme. Fees once deposited are not returnable / transferable.

#### **6. ENTRANCE TEST:**

- A. The Directorate of Distance Education shall conduct the Distance Education Admission Eligibility Test (DEAET) every year for selection of Candidates for admission into different Post Graduate Programmes under Directorate of Distance Education, Tripura University.
- B. Medium for DEAET shall be English except language subjects.
- C. DEAET shall be of 100 marks for each Programme. There shall be 50 questions each carrying 2 marks. Questions shall be Usual Multiple Choice Question. Duration of test shall be 2 hrs.
- D. The DEAET shall be conducted in accordance with the Syllabus of Undergraduate programme of Tripura University.
- E. Question Paper for DEAET shall be set and moderated by the faculty members to be appointed by the Tripura University authority.
- F. If a candidate is found to have adopted unfair means at the time of DEAET, his/ her candidature for admission shall automatically be treated cancelled.
- G. The DEAET shall be conducted at Tripura University, Suryamaninagar.

There shall be an Admission Committee which shall consist of the following–

## 8. CRITERIA FOR SELECTION:

- I. Selection shall be made on the basis of marks obtained by the applicant in the DEAET.
- II. If marks of entrance test of two or more candidates become same, then the following formula shall be followed, one after another, to break up the ties.
  - a. Candidates having Honor's in the relevant subject shall be given preference.
  - b. Marks obtained by the Candidate in the Degree examination shall be taken into account.
  - c. If the Marks in the Degree examination is also same then division and marks obtained in the next lower public examination (H.S.+2) shall be taken into account.
- III. Reservation of seats for SC/ST/OBC (Non Creamy Layer)/Persons with Disabilities (PWD) shall be as per the Central Educational Institutions (Reservation in Admission) Act, 2006 (No.5 of 2007) and Amendment Act, 2012 (No. 31 of 2012) published in the Gazette of India by the Ministry of Law and Justice, Government of India or as amended from time to time. 2% Supernumerary seats are available for students of Jammu and Kashmir.

## 9. COUNSELLING CUM ADMISSION:

- I. The merit list shall be prepared on the basis of the score obtained by the candidates in the DEAET. Short listed candidates (on the basis of merit list of DEAET) shall be called for Counselling cum Admission as per availability of Seats. The short listed students shall have to remain present with their original documents, admission fees etc. on the day of Counselling cum Admission, failing which Candidates Candidature shall automatically be cancelled.
- II. Students shall have to take admission on the day of Counselling by depositing the requisite amount of fees as prescribed by the Directorate of Distance Education, Tripura University.

**For any ambiguity in this Rules and Regulations, the interpretation or explanation of the Vice Chancellor shall be final and binding.**
